

Selling Pigs At A Show??

If you intend to sell pigs at a show you need to ensure that you take not only your movement licence's both **TO & FROM** the show but that you also take a **Show Sale Template** to give to your buyer (You can print as many of these as you need) from the "Help" tab at the top of the www.eaml2.org.uk website – look for "Show Sale Template"

Licence **TO** the show

Licence **FROM** the show

If the pigs are to go straight to Abattoir from show then you will not only need to supply the Abattoir with a "Show sale form" but also a completed separate Food Chain Information Form (FCI) which again you can print from the "Help" tab at the top of the www.eaml2.org.uk website – look for "Separate Food Chain Document"

FOOD CHAIN INFORMATION: PIGS

1. Production site details

This information should be received initially and retained for each site supplying pigs to the slaughterhouse, and up-dated whenever changes occur.

You need to hand write the "Show sale" form for your buyer and include the movement reference on the licence you have used to take your pigs to the show (Example 3PUUQH as shown on image) if pigs are going to Abattoir include the completed FCI Form as well
